### **Old Business:**

- Budget and Membership – KMHC account balance is \$13,651.01 We expect to end the year with more carryover than recent years – close to \$10,000. Expenses for web hosting and zoom hosting have increased, income from memberships and Advocacy Day have increased.

### **New Business:**

- Parity Committee - Paid Internship Proposal - [see proposal](#) Board supports the work of the committee and their efforts to raise \$3,000 donations in order to contract coordination services. Committee has raised commitments of approximately \$2000 to date from member organizations. **Motion approved** to provide umbrella authority to committee for contracting and contribute \$500 to contract.
