Big Tent Coalition - Mike Burgess – Following KDADS work for the ARPA HCBS funds process. Also developing recommendations for the new MCO contracting for KanCare.

KanCare Advocates Network – Network involved in the planning for the Policy Retreat in the fall that includes Big Tent Coalition, KMHC, Disability Rights Center, and KAN. Communicating with KDADS regarding the distribution of the ARPA stimulus funds for HCBS waivers. Subcommittee working on recommendations for KDHE procurement process for KanCare MCOs.

988 Advisory Council – The Council is meeting regularly and focusing now on how to make the pieces fit together. There will be a 7-9 month process for onboarding for the response network. Johnson County Mental Health, ComCare, and Kansas Suicide Prevention HQ will form the initial network to

answer calls to 988. The deadline to submit a draft plan to Vibrant for the system is the end of September.

Question of funding remains. Kansas – and many other states – are getting hung up on the idea of taxing phone lines. It isn't popular. The federal law doesn't include any funding for the states implementation and operation. This is going to be a continuing problem as we work to advocate for support for a specialized behavioral health response.

11:00 a.m. Guest Topic: Agreement to address Olmstead concerns for residents of nursing facilities for mental health - TILRC and Disability Rights Center See press release See agreement

Topeka Independent Living Resource Center (TILRC) and Disability Rights Center of Kansas (DRC), acting on behalf of their constituents with mental illness, have reached an agreement with the State of Kansas to expand services and provide more community residential options for individuals living in, or at risk of being admitted to, Nursing Facilities for Mental Health (NFMH). Under the agreement, the Kansas Department of Aging and Disability Services (KDADS) and the Kansas Department of Health and Environment (KDHE) will provide supports and services to allow people with mental health disabilities to avoid institutionalization and live in community-based, integrated settings. TILRC was represented in negotiations by attorneys from AARP Foundation, DRC, the Center for Public Representation, and Shook, Hardy & Bacon.

Under the agreement, over the next eight years the State will develop and expand a wide range of mental health services for NFMH residents, as well as integrated community services throughout Kansas. The reforms will include the creation of several hundred supported housing units; mobile crisis and assertive community treatment teams; supported employment programs; and peer support services.
